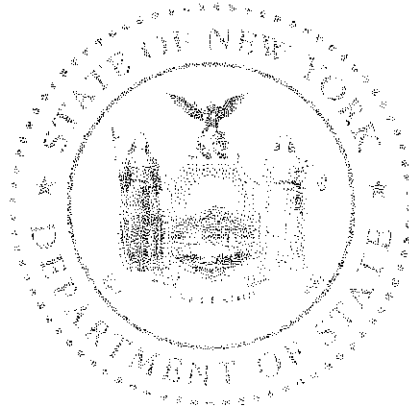

FIRST: The name of the corporation is New York Jobs with Justice, Inc.

SECOND: The certificate of incorporation of the corporation was filed by the Department of State on May 30, 2002 under the Not-for-Profit Corporation Law.

THIRD: The corporation is corporation as defined in subparagraph (a)(5) of Section 102, and is a Type C corporation under Section 201, of the Not-for-Profit Corporation Law

FOURTH: The amendment of the certificate of incorporation of the corporation effected by this certificate of amendment is to change the name of the corporation from "New York Jobs with Justice, Inc." to "ALIGN: The Alliance for a Greater New York, Inc." 
The name of the corporation is ALIGN: The Alliance for a Greater New York, Inc. (the "Corporation").

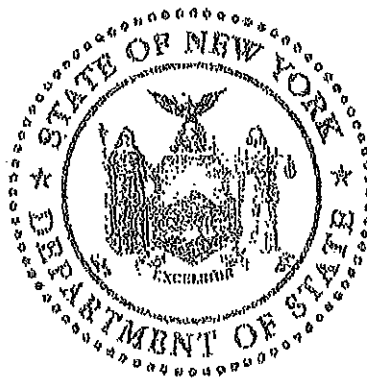
